BURGMANN ANGLICAN SCHOOL INCORPORATION ORDINANCE 1998¹

AN ORDINANCE

To provide for the incorporation of the Burgmann Anglican School Board.

Recitals

- (a) The Bishop-in-Council of the Diocese of Canberra and Goulburn has—
 - (i) by resolution approved the establishment of a school in Gungahlin in the Australian Capital Territory under the name of the Burgmann Anglican School as an institution of the Anglican Church of Australia within the Diocese; and
 - (ii) by ordinance constituted the unincorporated body of persons specified in subsection 6.1 of the Burgmann Anglican School Ordinance 1998 as the Burgmann Anglican School Board for the purpose of managing the Burgmann Anglican School.
- (b) The Synod of the Diocese has, by the Anglican Church of Australia (Bodies Corporate) Act (Exercise of Powers) Ordinance 1994, delegated all of the powers, authorities, duties and functions of the Synod as relate to any act, matter or thing arising under the Anglican Church of Australia (Bodies Corporate) Act, 1938 of New South Wales to the Bishop-in-Council, as constituted in accordance with the Canberra and Goulburn Bishopric, Synod and Bishop-in-Council Ordinance 1959 as amended, in its capacity as the Standing Committee of the Synod.
- (c) The Bishop-in-Council in its capacity as the Standing Committee of the Synod considers it expedient for the purpose of managing the Burgmann Anglican School that the persons who for the time being are the members of the Burgmann Anglican School Board should be constituted as a body corporate.

The Bishop-in-Council, in its capacity as the Standing Committee of the Synod of the Diocese and in exercise of its powers under the

Anglican Church of Australia (Bodies Corporate) Act (Exercise of Powers) Ordinance 1994 and the Synod (Delegation of Functions) Ordinance 1998, therefore enacts:

1. Short Title

1.1. This Ordinance may be cited as the Burgmann Anglican School Incorporation Ordinance 1998.

2. Commencement

2.1. This Ordinance commences on 12 October 1998.

3. Declaration of expediency as to incorporation of the Burgmann Anglican School Board

3.1. It is declared that it is expedient, for the purpose of managing the Burgmann Anglican School, that the persons who for the time being are the members of the Burgmann Anglican School Board should be constituted as a body corporate under the name The Burgmann Anglican School.
