### CANBERRA CHURCH OF ENGLAND OF ENGLAND GIRLS GRAMMAR SCHOOL (ELECTION OF NEW TRUSTEE) ORDINANCE 1982<sup>1</sup>

#### AN ORDINANCE

To elect a separate trustee for certain church trust property held for purposes of the Canberra Church of England Girls' Grammar School

WHEREAS Canberra Church of England Girls' Grammar School, a company incorporated in the Australian Capital Territory (hereinafter referred to as the first trust company) is the trustee of certain church trust property held for the development and operation of the school maintained and operated by it on behalf of the Diocese of Canberra and Goulburn (hereinafter referred to as the Diocese) under the name Canberra Church of England Girls' Grammar School (hereinafter referred to as the School):

AND WHEREAS the Anglican Church Property Trust Diocese of Canberra and Goulburn (hereinafter referred to as the Property Trust) is the trustee of \$760,559.07 for the purposes of the development and operation of the school:

AND WHEREAS the first trust company has accumulated reserve funds amounting to \$35,543.65 for the purposes of the development and operation of the School:

AND WHEREAS the first trust company has informed the Standing Committee of the Synod of the Diocese that it is desirable that the moneys so held by the Property Trust and the moneys so held by the first trust company be held by Gabriel Foundation Limited, a company incorporated in the Australian Capital Territory, the objects of which include the object of acting as trustee of church trust property held for the Diocese (hereinafter referred to as the second trust company) and be administered as part of the Gabriel Foundation for the purposes of the School:

AND WHEREAS the Property Trust has agreed to the second trust company being appointed trustee of the abovementioned moneys held by the Property Trust:

NOW THEREFORE the Standing Committee of the Synod of the Diocese, acting in pursuance of the powers conferred on it, during the recess of the Synod of the

Diocese, under sections 16 and 25 of the Anglican Church of Australia Trust Property Act, 1917, of New South Wales (in their application in the Australian Capital Territory) and of all other powers it thereunto enabling, ordains as follows:-

**1. SHORT TITLE**

1.1 This Ordinance may be cited as the Canberra Church of England Girls' Grammar School (Election of New Trustee) Ordinance 1982.

**2. ELECTION OF TRUSTEE**

2.1 There shall be a separate Trustee for the church trust property described in the First Schedule in place of the Property Trust, and the second trust company is hereby elected as the separate trustee of the church trust property so described.

2.2 There shall be a separate trustee for the church trust property described in the Second Schedule in place of the first trust company, and the second trust company is hereby elected as the separate trustee of the church trust property so described.

**3. INVESTMENT**

3.1 The Second Trust Company may pool the church trust property that becomes vested in it by virtue of this Ordinance with other church trust property held by it in the Gabriel Foundation for the purposes of investment.

**FIRST SCHEDULE**

**Description of Church Trust Property**

Moneys aggregating to \$760,559.07 (whether held in cash, with a bank or on deposit or invested with a bank, fund or other body) held by the first trust company as a reserve for the development and operation of the School (including the investments held by the first trust company and representing those moneys).

**SECOND SCHEDULE**

**Description of Church Trust Property**

Moneys aggregating to \$35,548.65 (whether held in cash, with a bank or on deposit or invested with a bank, fund or other body) held by the first trust company as a reserve for the development and operation of the School (including the investments held by the first trust company and representing those moneys).

**Notes:**

Passed without amendment by Bishop-in-Council on 15 December 1982 and assented to by Bishop Cecil on 15 December 1982.
