BINDA LAND VESTING ORDINANCE 2005¹

AN ORDINANCE

TO VEST certain lands in the Binda Parish in the Anglican Church Property Trust.

RECITALS

1. The land being Lot 22 Section 32 village of Binda, County of Georgiana comprised in Deposited Plan 758110 is presently held in trust for the Anglican Church in the name of trustees Henry Carr, William McDonald and Guildford Dudley Hay.
2. The land being Lots 24 and 25 Section 32 village of Binda, County of Georgiana comprised of Deposited Plan 758110 is presently held in trust of the Anglican Church in the Diocese of Canberra and Goulburn in the name of the trustees, Henry Carr, William McDonald, Guildford Dudley Hay and James William Bray.
3. Henry Carr, William McDonald, Guildford Dudley Hay and James William Bray are all deceased.
4. The Parish of Binda has requested that the Anglican Church Property Trust, Diocese of Canberra and Goulburn be appointed as trustee of the lands referred to above.

Now the Bishop-in-Council under powers given to it by section 3 of the Synod (Delegation of Functions) Ordinance 1988 in exercise of the powers under section 19 of the Anglican Church of Australia Property Trust Act 1917 of the State of New South Wales enacts.

1. SHORT TITLE

- 1.1 This Ordinance is the Binda Land Vesting Ordinance 2005.

- 2.1 Consent of the Synod under section 19 of the Anglican Church Property Trust Act 1917 of the State of New South Wales to vest the land being Lot 22 Section 32 village of Binda, County of Georgiana comprised in Deposited Plan 758110 in the Anglican Church Property Trust of Canberra and Goulburn

- 2.2 Consent of the Synod under section 19 of the Anglican Church of Austral Property Trust Act 1917 of the State of New South Wales to vest the land being Lots 24 and 25 section 32 village of Binda, County of Georgiana comprised in Deposited Plan 758110 in the Anglican Church Property Trust, Diocese of Canberra and Goulburn.
